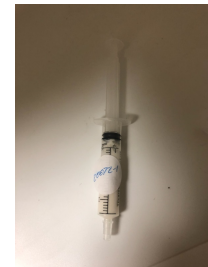

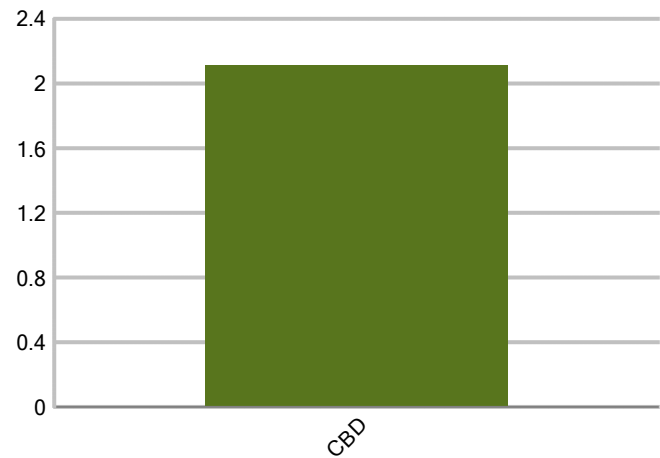

Cannabinoids (% weight)



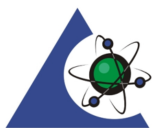
